Trafficking for the OSCE Parliamentary Assembly. Previously, he served as Co-Chair and highest-ranking House member of the bipartisan House/Senate Commission on Security and Cooperation in Europe (CSCE) serving as chairman five times, and served as Chairman of the Veterans Committee (two terms), the Foreign Affairs Subcommittee on Human Rights and International Operations, and the Subcommittee on Africa.

- 6. **CA MP Colin Carrie,** a Member of Parliament for Oshawa, assumed office in the Canadian House of Commons in June 2004. In April 2024, he announced that he would not seek re-election. BEGIN TRANSCRIPT

Frank J Gaffney: [00:00:05] Welcome to the sovereignty Summit. My name is Frank Gaffney. I'm the executive chairman of the center for Security Policy and the co-founder of the Sovereignty Coalition, which is very proud to bring you this vital program we have with us in person some very important senior influential legislators here in the United States. And we have with us through the miracle of zoom, many parliamentarians from around the world. We will be asking each of them to speak briefly about our shared concerns about the World Health Organization's bid to transform itself and its director general, Tedros Ghebreyesus, into the global health dictators. That would pose a very profound threat to the sovereignty of all of our nations, as well as the freedoms, the medical freedoms, among other things of their peoples. We are going to be going to these distinguished guests momentarily. But before we do, I did want our co-founder, Reggie Littlejohn, the president of Women's Rights Without Frontiers, to both bring us in with prayer because we need it big time. And she brings to this the distinction of both Methodist minister and a practicing Catholic, and we're delighted to have her. She will be speaking more to us in a moment. But first, a prayer and a welcome word from you, Reggie.

Reggie Littlejohn: [00:01:41] Thank you. Frank. Dear God, we come before you now desperate for your help. This problem is too big for us. You see what the globalist cabal is doing? You see their plans. You see all the different ways that they are trying to steal our freedoms and our national sovereignty. But they're nothing compared to you, oh Lord God. So we appeal to you to help us to counter them, Lord. And we just pray for your grace and your blessing and your power. And we pray that this world, this world would go forth over all the world, and that the world would rise up and throw off the chains that these globalists are trying to, to enslave us with through, most recently, this World Health Organization, um, pandemic treaty and international health regulations. So, Lord, we lift up this summit to you. We ask that you would bless it. Amen.

Frank J Gaffney: [00:02:41] Amen. Thank you. Reggie. Um, a quick word of welcome as well.

Reggie Littlejohn: [00:02:47] So my name is Reggie Littlejohn. I am the founder and president of Women's Rights Without Frontiers and also Anti-globalist International and the co-founder of the Sovereignty Coalition. And it is with great pleasure that we have this summit today because this the World Health Organization, through the vote

that's coming up at the end of May, is seeking to install a biotech totalitarian state. And we have had great success in the United States raising the visibility. This is our first international, um, summit and hopefully the first of many. But we we all need to grow together and join our voices together to throw off this globalist plan.

Frank J Gaffney: [00:03:30] Thank you. Thank you, Reggie Littlejohn. I'm very pleased to be able to go next to a man who was really instrumental in bringing this program into being, not least because of the inspiration that he has provided to all of us who have been concerned about, well, among other things, what happened to us in the pandemic when the director general of the World Health Organization, Tedros Ghebreyesus, um, provided well, Malfeasant advice, uh, what he was capable of doing at the time, and it sheds great light on what might come next if he gets vastly expanded powers. Senator Ron Johnson from Wisconsin is a businessman. He chose to serve his country by dint of the sense of really the emergency that it was facing in so many respects. He was recently re-elected, and we couldn't be more proud to have him here as, uh, again, an inspiration as well as our leader in the sense that he has been holding informal hearings, uh, many of them in recent years to expose truths, unsavory, sometimes truths, but truths nonetheless that we need to know about the vaccines, about the damage they've done, about the mandates that were in part brought to us by Tedros Ghebreyesus. So we've asked him to speak altogether too briefly. But to help us kick this off, um, again, I'm proud to call him a friend as well as a mentor. And with you here, sir, I believe we're off to a very important start. Over to you, Senator.

US Sen Ron Johnson: [00:05:11] Well, thank you, Frank. Thank you. Reggie, I want to thank everybody involved with the Sovereignty Coalition. And thank all of you for joining us. In the earlier test run, Frank used the word stealthily, and it's very appropriate. Uh, the globalists, the tyrants, they gain power through deception. And that is what they're trying to do here. So it wasn't very many months ago where this was under everybody's radar screen. There were a few people online, people like Frank, people like Reggie, you know, others in the alternate media. Uh, Congressman Bachmann, uh, there were people that were aware of this, but the vast majority of of members of Congress, uh, parliamentarians around the world were completely unaware of this, uh, upcoming power grab. But because of the extraordinary efforts of the sovereignty coalition pushing and pushing to to expose this truth and to make sure that the people were aware of this, now we have this summit and we have members from different parliaments all around

the world. We had a zoom call last week with members of the Knesset. Uh, you know, these are Israelis who are under an existential threat but are aware that we are all under a threat of our loss of sovereignty, loss of our own personal health, autonomy. That's what's at stake here. So again, I just want to thank everybody for being involved. I want to thank everybody who have had their eyes opened. Uh, just remember, it's it's everybody's trying to make us forget, uh, the petty tyrants, the loss of freedom during the pandemic.

US Sen Ron Johnson: [00:06:44] You know, the mask mandates, the vaccine mandates, the shutting down, the destruction of our economies. Uh, none of these things had to happen, but they were pushed by by people who seized and pushed fear to gain control and cost us our freedom. That's what they want to do here with these, uh, who agreements. And again, I just want to thank everybody for opening up their eyes. Uh, I'm asking all of you to expand the reach of this, uh, make sure that more and more people have their eyes open. It's the only way. The only way we're going to be able to stop this. Uh, I was able to get all 49 Republican senators to sign a letter to President Biden to ask him to withdraw from these talks. And if he does make some agreement to bring it before the Senate for discussion and ratification, the only reason I was able to get 49 senators is because there is growing awareness. And those 49 Republican senators understood that the people that support them were expecting them to step up to the plate and stop this. Uh, and that's what we're asking all of you to do. Step up. The plate. Use what power you have. Let's stop this before we lose more of our freedoms. But thank you very much.

Frank J Gaffney: [00:07:53] Senator. Thank you very much. This is the perfect keynote. We want to recognize, particularly your leadership in bringing every member of the Republican caucus in the Senate into alignment in opposition to these treaties. Um, thank you for what you've done with that, uh, inspiration. I believe it's important to note that it is also encouraged, 22 attorneys general across the United States to do the same. And now, just yesterday, 24 governors as well, to stand up and say, no, not now to these treaties and and also to the point that you've made, sir, that the Senate of the United States must, uh, affirm whatever comes of these in the end. Not now, hopefully not next week, but in the future. If they do emerge, um, we're going to be sort of playing this a little bit as it lays. We have a number of members of Parliament and other officials from around the world that we're going to be featuring in the course of the program. Um,

I'm going to call on them as best I can determine that they're there and available and willing to say three minutes worth of remarks about the subject at hand. Um, this Sovereignty Summit's focus on not having approval of these treaties, uh, in the next week or so. Um, I think we will go, if we can, to, um, the. Member from the Italian Parliament do have a Claudio Borghi. Um, he is, uh, representing himself, of course. And hopefully he is able to speak to the sovereignty and the needs of the people of Italy as well. Are you there? Uh, member of Parliament. Borghi.

IT Sen Claudio Borghi: [00:09:50] Wonderful. Thank you for inviting me in for, uh, for this time, uh, in, uh, in Italy, uh, the level of awareness is pretty high. Uh, thanks to, uh, our government coalition. Uh, I, I, I published, uh, I published a post on it, uh, that at the moment is running at 2.2 million views regarding what is going on, uh, on the W.H.O. pandemic treaty. Uh, and, uh, I made, uh, many official, uh, request to our health minister in order to prepare him to say no. Uh, at the moment, I'm pretty convinced that, uh, that Italy is going to say no to the treaty. Uh, and the last, uh, uh, the last, uh, uh, interlocution that, uh, that I had with, uh, with our minister goes in this direction. I say I'm pretty convinced and not, I'm sure, because I know how these things goes. I know that there are pressure, international pressure, that you never know until the last minute how it goes. Uh, but at the moment, the official position for Italy is. No, uh, and I think that, uh, it's, uh, it's a good, uh, it's a good start. Uh, one, uh, advice that I have to give to all the members of the sovereignty coalition is, uh, not fall in the trap to, uh, accept any kind of amendment because they will say that they will put some articles on new articles that, uh, uh, can, uh, soothe all your trouble and, uh, reassure you about the loss of sovereignty. Well, it's a typical trick we need. No. Pandemic treaty, not an amended pandemic treaty. So, uh, in in my opinion, this is the only risk that we have to, uh, to go from here to the Assembly. No pandemic treaty whatsoever, not an amended one.

Frank J Gaffney: [00:11:47] Um, we're going to hear next from a man, I'm pleased to say is in the room as well. His name is Congressman Chris Smith. He has served with great distinction the people of New Jersey in the United States House of Representatives for decades. He regaled me recently with the fact that he had presided over--not just attended--but presided over as chair something like 650, as I recall, hearings. So he knows what's involved in making these things work. And we're so appreciative of his patience with us. Congressman Smith has been a leader on human rights in general, and particularly is committed to protecting the people of the United

States and their human rights against the predations of people like Tedros Ghebreyesus. We're very pleased to have you with us. Congressman, over to you.

US Rep Chris Smith (NJ-D4): [00:12:40] Thank you so much, Frank. Thank you for your tremendous leadership and the sovereignty coalition for really being the group walking point to try to ensure that this egregiously flawed pandemic treaty does not go forward. Uh, I have been in Congress for 44 years. I have never seen such an effort to have a power transfer to unelected bureaucrats. That is to say, the W.H.O.. Uh, and Tedros, I've known Tedros for about 30 years, uh, including when he was the head of the, uh, health for Ethiopia. Uh, at that time, he had covered up, uh, some of the, uh, cholera outbreaks on behalf of Meles, who was then the dictator in that country. So there are many, many concerns about him. He got his job. But let's not forget it, uh, from, uh, XI Jinping in China, uh, both times. The first time. And then his reelection was all orchestrated by the Chinese Communist Party. Reggie Littlejohn, who has done an amazing job with for decades on behalf of women's rights, especially as it relates to China and the girl child there. Um, she has testified at many of our hearings, including, um, on behalf of Chen Kuan Jen, uh, when he was released against all odds. So she made a huge difference on that. So now she's speaking out again and again. How did Tedros, um, or how did Tedros get his job? Chinese Communist Party. So just make it very clear to everybody, uh, the source of this is coming from bureaucrats and one chief bureaucrat who has an egregiously flawed, just like the treaty itself, which is not finished, thank God.

US Rep Chris Smith (NJ-D4): [00:14:16] Uh, so I just look at the source, uh, Michele Bachmann is we miss her so much in Congress. What a tremendous asset she was and continues to be in all of the leadership roles she takes on. Thank you. Michele, you you are so articulate and so, uh, strong. Uh, and I do believe when the time comes, when when this flawed treaty does not come into fruition, uh, it'll be because of the great work that's being done by the Sovereignty coalition and all of your leadership. Uh, so I thank you for that. Yesterday, I asked the Secretary of State, Blinken, a very specific question about how the Who is breaking its own rules in rushing this through. Uh, I pointed out that there are a number of of instances where there needs to be at least four months when the text is made available to make a decision. Uh, they want to rush this through within a week or so. Uh, I've gone through every iteration of the text, uh, although the latest one we don't have, and that is very troubling. Uh, so I so I asked him a question,

two questions about this flawed process and also about whether or not he would submit it, they being the administration, the Biden administration, uh, for ratification. And, Senator Johnson, what an amazing thing to get all 49 Republicans to say, submit this for advice and consent.

US Rep Chris Smith (NJ-D4): [00:15:34] Do not, I say again, do not just do it by executive agreement. That's what the Obama administration did with regards to Iran, uh, with the nuclear deal, instead of submitting it as they should as a treaty to the Senate, where it could be looked at and scrutinized up or down vote. Uh, and they also have done it with other things as well. And now we have a reprise of that. Uh, potentially. He did not answer that question. I asked him very pointedly about that. Secretary of state did not say whether or not they would submit it for ratification. But he did say, and I'll quote him briefly, um, uh, on the pandemic treaty, the way things stand right now, I don't know that that coming to a conclusion and it's coming to a conclusion in the near term. There's just not consensus on it. It's something we continue to work on, but continue to work on making sure that we uphold our own interests and values, including, for example, intellectual property. So it doesn't sound like a rousing endorsement, but frankly, I've worked over at the UN. For years. I was a congressional delegate four times. Uh, all of a sudden, something can be a big agreement burst out. Um, and next thing you know, uh, it's on its way to all the countries, uh, for ratification. And my fear is that this president will just ratify it with his own signature rather than submitting it to the Senate.

US Rep Chris Smith (NJ-D4): [00:16:51] And one of the things that I pointed out and I pointed out, you do it all the time, is that we're going to be obligated by the billions of dollars, and they won't even tell us that that's against the rules. Uh, that they're not following as well, billions of dollars after the fact. Uh, one of the one of the earlier texts that I think it might be in the same, uh, current one. We don't know, said that by 2026, they'll tell us what the US taxpayer has to fork over. And that goes for taxpayers elsewhere in the billions, and it will be treaty obligation. This isn't an admonishment or a sense of the UN or a sense of Congress type of thing. This is binding, and I think a lot of people don't realize that, too. Uh, so finally, uh, and I, you know, we've had very good press conferences, Frank, as you know, uh, in the past, all of you have spoken at them, uh, and it made it very clear that it is filled to overflowing with wrongful policy. Uh, I mean, what are they going to do when they. I'm looking over at one of my staff directors

and I'll leave, uh, and I went to, uh, uh, to Geneva and lobbied a number of who delegation countries that are deployed there. I was kind of shocked at the lack of understanding.

US Rep Chris Smith (NJ-D4): [00:18:01] They are talking about how, you know, they're not having any real input. It's being, you know, here, here's the text. Do you agree or disagree? It's not really a negotiation. Uh, they claim and I know the UK has had some real problems as well. Thankfully. Uh, I think theirs has to do with the, the mandatory conveyance of, of whatever we our reaction is to whether it be vaccines to the next pandemic, uh, that upwards of 20% has to be forked over, uh, from their arsenal and ours as well. You know, whether you agree or disagree on a vaccine, some are good, some are absolutely horrendous. Um, we need to be, you know, we're just going to be told, you know, we don't have a vote on Congress. It's going it's on its way. And so I'll just finish with saying, um, lack of transparency, lack of transparency, lack of transparency, and we will rue the day if we don't stop this and stop it now. Thank you, thank you. Thank you guys. You said real quick. We have a letter. It's on your website. And you guys have been fantastic. Uh, we have 21 countries, 83 signatories. The deadline is is Saturday. Uh, and it raises some of these questions again about the process, lack of due process that they are so-called committed to. Uh, and I would hope that people would look at it, members of Congress, members of parliaments and sign it. Thank you.

Frank J Gaffney: [00:19:21] Thank you again, Congressman Smith. We're so glad that you joined us as well as for your leadership. And again, that letter is critically important. You can find how to sign up to it at review the Who review the Who. Um.org I believe it is. Um, we're going to turn next to a member of parliament across our northern border. His name is Colin Carey. Um, if you're there, Mr. Carey, could we go to you next?

CA MP Colin Carrie: [00:19:52] Well, thank you very much for calling this important meeting. Um, since Covid 19 lockdowns and mandates, Canadians have seen our sovereignty, our charter rights and our civil liberties tested trust in our institutions, our public health system challenged, and ordinary Canadians realized something was very wrong in Canada. Remember, we have a prime minister. When asked which country he admired the most, do you remember what he said? He said he admires the basic dictatorship of China. Yes, China. You may think our PM's ideas are wacko, but sadly,

this is the truth that Canadians face today. While our government has signaled acceptance of this treaty, many of my constituents do not agree and have outstanding questions. Our freedom of speech, freedom of movement, freedom of consent and medical treatment were all enthusiastically challenged by our own government in Canada under the Covid dictates, centrally controlled and communicated by the W.H.O., Canada's PM intentionally created an identifiable minority group, anti-vaxxers, and gleefully used all the power of the Canadian government to marginalize, dehumanize and keep over 6 million Canadians from fully participating in Canadian society. These Canadians, many with health concerns, were called misogynists racist with unacceptable views, and they should not be tolerated. We all remember the facade of the Illegal Emergencies Act and use how it was used to freeze bank accounts. Businesses were shattered, seniors and loved ones died alone, and our children's education was compromised and churches were closed.

CA MP Colin Carey: [00:21:21] Canadians do not want this to happen again. The Who says the new treaty is non-binding. My constituents are asking me if that's so. Why did they remove the term non-binding from the definitions? We know that the current treaty acknowledges that the Who only has an advisory board that issues recommendations. Not so with the new treaty. If the Who's new amendments to the Ihr would would not bind nations, then why is the Who self appointed as the primary decision making authority or the directing and coordinating authority when an international pandemic emergency is declared, what is the definition of an emergency? Who decides who complies? If Canadians want out of the treaty, what's the process? What's the cost? What criteria defines a pandemic or global emergency? Colleagues. This treaty will legally compel actions based on decisions that are made by unelected Who technocrats, the same technocrats who tasked themselves to declare an emergency at their whim. Why would any country sign on to a new treaty when we haven't conducted a serious evaluation of the last pandemic policy response? Will this treaty institutionalize whose Covid pandemic mistakes? Why did they demonize and ignore legitimate opinions and data from esteemed, esteemed scientists? Why censor valid, differing opinions? Who decides what constitutes disinformation? Misinformation? Colleagues, this is about our sovereignty, our nation's right for self-determination. Canadians want local demographics acknowledged, not ignored. Decisions made by Canadians, for Canadians. Thank you very much.

Frank J Gaffney: [00:22:58] Thank you very much, Mr. Kerry. It turns out that what is happening in Canada often has an impact here as well. And so those of us in the United States are especially appreciative of your leadership. Um, I'm very pleased to say we have a former member of Congress. Um, she has been introduced in a way, by her friend and colleague Chris Smith. They served together for many years. Her name is Michele Bachmann. Uh, I will say that Michele Bachmann is the person who put me on to this issue, and she did so in her characteristic fashion. That was a real call to arms. Everyone needed to get involved in this fight because she understood immediately what it meant for the sovereignty of the United States and others around the world, for that matter. Uh, and not least for our freedoms, our constitutional rights. Uh, we're delighted to have her with us. She's literally just gotten off the plane from Nashville, Tennessee, and we're delighted to. Turn over the floor to her briefly. Michele Bachmann.

Hon. Michele Bachmann: [00:24:02] Thank you, Frank. Thank you. Members of the Sovereignty Coalition, I want to thank Senator Ron Johnson of Wisconsin. I want to thank the leadership of Congressman Chris Smith from new Jersey, who has been tireless on this issue, who has held hearings, who has written letters, who has done everything that he can as a member of Congress to let other members of Congress know the serious repercussions of this issue passing in the World Health Assembly. And I want to thank you for your leadership, Congressman Smith. I also want to thank other members of the United States Congress, part of this hearing. Members of the governmental bodies that we've heard from are already and those that we will yet hear from, from around the world, each one of you, no matter how large, how wealthy, or how important your country may be viewed at the United Nations, every country is significant in their ability to weigh on this issue, and I want to thank each one of you who are participating every day on this issue, and particularly as part of this zoom call today, and also the distinguished speakers who will be a part of this effort. As Frank Gaffney said, my name is Michele Bachmann. I am a former member of the United States Congress. I am now the dean of the Robertson School of Government at Regent University in Virginia Beach, Virginia. It was two years ago that the Biden administration initiated proposals for changes to the international health rules that govern the World Health Assembly in Geneva, Switzerland. I had the privilege of attending last year in Geneva, Switzerland, the World Health Assembly, and saw with my own eyes and heard with my ears the proposals almost too unbelievable to believe that were being put forward.

Hon. Michele Bachmann: [00:25:56] If the proposed amendments passed last year and the year before, they would have robbed all nations of their decision-making authority, and instead, they would have created the structure for global government. I repeat, the 194 nations of the United Nations would transfer national sovereign power over their citizens to a national to a global government. The Biden administration failed two years ago, as well as last year, to create the platform for global government through the World Health Organization. But since then, the Biden administration has convinced other nations to join them in this evil quest. The World Health Organization is the health care face of the United Nations. However, these proposals aren't about advancing health or public health. They're about creating a global structure of control over nearly every human, every animal, every bug, every fish, every creature, and over all land use on Earth, such as the breadth and the scope of this proposal that's being put forward at the World Health Assembly. Our US Constitution prohibits our federal government from giving sovereign decision-making power to the United Nations. Yet that is exactly what the Biden administration and other nations are trying to do next week, when the World Health Assembly convenes in Geneva, Switzerland. If the nations fail again to achieve global governance in Geneva, another attempt will be made at the United Nations when they gather this September 2024, in New York City for their annual meeting at the iconic United Nations Building at what the UN is calling the summit of the future, look at the United Nations own website.

Hon. Michele Bachmann: [00:27:58] Type in the search engine summit of the future. They boldly proclaim the United Nations goal of achieving global government at the summit of the future. If the transfer of power from nations to international bodies is achieved. Recognize. The largest voting bloc at the United Nations is the OIC. That's the organization of Islamic Cooperative. The OIC would undoubtedly pressure the World Health Organization global power structure to impose a global boycott, Divestment and Sanctions movement against the Jewish State of Israel, meaning boycott, divestment, sanction used at will by the World Health Organization against the Jewish State and Jews everywhere across the world against Israel. Bringing Israel to her knees economically or. Any other nation that the World Health Organization would want to punish for opposing their will. This is warfare by another means. All nations must wake up immediately and loudly reject the imminent loss of their sovereignty over national decision making to the United Nations. Remember, the World Health Organization is the face of health care at the United Nations. Future generations depend upon our victory in

this work. I want to thank Senator Johnson, Senator Smith, Frank Gaffney of the Sovereignty Coalition, Reggie Littlejohn, and all of you who are participating in this important call today. You are courageous for holding this important meeting. I respectfully submit these remarks for your careful consideration, and I yield back.

Frank J Gaffney: [00:29:53] Thank you. Michele Bachmann, it's so great to have you here. And as Congressman Smith said, we wish you were here permanently rather than just passing through. Um, to your point about Gaza, I think this is not something that the OIC, the Organization of Islamic Cooperation, would necessarily need to pressure, uh, Tedros Ghebreyesus to do. He's he's also already said, as he has in so many of these instances, that he considers Gaza to be basically a public health emergency of international concern. So I think that's where we would see him go voluntarily. Um, we're going to try to take two of our foreign contributors who, uh, have to leave uh, soon. And I want to make sure we catch both of them if we can. Um, first up is a woman who has distinguished herself in the Netherlands, uh, by having brought the motion that has moved the Dutch government, I think, in the direction of basically saying, uh, not only not now, but not never to these treaties. Her name is, uh, and I may be massacring it. Mona. Mona Kriejzer, I believe it is. And, uh, we're very pleased to have her with us. Um, are you there, ma'am? And can you take the floor now?

NL Rep Mona Kreijzer: [00:31:11] Yes, I am, and thank you for having me. Uh. It's Mona. Well, that's a little bit international. And the last name is "Kaiser." Like the Emperor. You could translate, but on the other hand, I'm a very down to earth dutchie. So some of the things I've been listening to wouldn't be mine. Uh, exact words. But where we agree is that the procedure which has been followed isn't the correct one. The procedure, uh, the W.H.O. followed, and, uh, some parts of the treaties, both of them, um, are going far too far as I, uh, look at it, um, I, um, uh, put forward a motion, uh, yesterday evening, and, uh, the Dutch parliament agreed with it. Where, um, the parliament, uh, asked the minister, uh, Mrs. Dijkstra, uh, at the wha uh, coming week to abstain from agreeing with the results, um, which will be put on, uh, on, on the table over there. And, I would much preferred, to vote against it, but I realized that, I wouldn't find a majority in the Dutch parliament. So by making sure that she will abstain from agreeing, it gives room to the new Dutch government, which will be, in place within a few weeks to look very closely at what is on under the table, whether it is the pandemic instrument or the IHR and the changes in it. I'm concerned because up to this moment,

we don't know what the definition of a pandemic emergency will be. And because the director general is in charge of declaring one and and then has all, the possibilities to put forward, things that he thinks it's good to do. And then, because the procedure in the treaties makes it possible to declare what will happen in the Netherlands. So I'm a very down to earth dutchie, but I like to be in charge of my own country. Thank you very much.

Frank J Gaffney: [00:33:58] We appreciate your inspiring leadership and hope that it will be now replicated elsewhere, both in Europe and across the world. We have with us another of our wonderful members of Congress. I'm going to ask his forbearance, though, if we could just take one more of our foreign guests who I know has to leave. We'll be right back with the Honorable Ralph Norman of South Carolina. But before we do, we have a member of Parliament from Portugal by the name of. I'm going to ask her this, too, I'm afraid. Pedro dos Santos-Frazão. I think it may be something like that if you are with us, sir. The floor is yours.

PT Dep Pedro dos Santos-Frazão: [00:34:40] And thank you so much for introducing me. I am with you and thank you so much for introducing me and your. Your Portuguese is quite fine. Thank you so much. I will present myself. I'm a veterinary doctor. I am an MP from Portugal. I'm also the vice president of the third political party in Portugal. And I want to thank you for having me today and for speaking out worldwide of this international health regulations. I don't know about the rest of the world, but here in Portugal, this Who international health regulations that have been, uh, has been largely hidden from public opinion. And, uh, I think today we want here that sovereign nations are not interested in giving, uh, our powers to this dark globalist interests. Uh, the Who will discuss this treaty, an international legal document that will strengthen, uh, supposed global response to a possible public health emergency. But they also want to approve around 300 amendments to the international regulations whose negotiations are being conducted in secret and behind closed doors. And we cannot accept that. And it's not the first time, because in 2022, the Who also introduced amendments that were not voted or not endorsed with transparent processes and was, uh, they they were aimed to reinforce the Who powers such as power of to declare a global public emergency in cases of human health, animal health or environmental well-being. This is defined as a global response with vaccines, medicines, medical resources. So in in a practical way, we will give to the Who the power to define also the official narrative of of

uh emergency crisis, identifying the narratives and the stories and even pointing out the sources of information that must be, uh, combated. So we don't want to, uh, give away our sovereignty. And to people that were not elected by Portuguese and, uh, that will are not known by the Portuguese people and who to who the Portuguese authorities cannot, uh, engage.

PT Dep Pedro dos Santos-Frazão: [00:36:58] So at this point here in Portugal, my party is being the one of the public voices speaking against this. And I also, I confess, gentlemen, and that, uh, I am astonished with the silence of the left parties. I don't know about the rest of the world, but here in Portugal, the left and the extreme left parties, uh, are. Benched to the strength of the property and to the capital. That will give power to the to the who that is being. Um, I think, uh, depends on corporate foundations and institutions linked to the pharmaceutical industry. This is an obvious conflict of interest, because whoever has the power to declare a pandemic or a public health crisis is also financed by who allegedly can offer a cure for this crisis or this pandemic. We cannot be subservient to that. We must, uh, we must stand all together against this and to, uh, speak out and speak worldwide so that the public and the, the people around the world know what is is going on. What and what is going on is that we are facing with a corrupted elites, and above all, they are corrupted with money, and they are also corrupted with their moral values. So I want to thank you very much for having me today for, uh, doing this organization. Uh, I think it's it's, uh, it's it's very military that that we are we are here today discussing these issues. I hope that will they will impact in public opinion all worldwide. And you can of course, uh, count on me to be an another, uh, voice to increase the awareness to this subject. Thank you so much.

Frank J Gaffney: [00:38:54] Thank you. This is, uh, an extremely encouraging, um, call to action. And we definitely wanted heard around the world. And this program, this summit is, uh, our hope is that it will be, as was previously mentioned, the first of many of these opportunities for us to amplify the voices of people who cherish freedom as we do, and who want to make sure that it survives. Uh, the the next week at the World Health Organization's World Health Assembly meeting, we're going to turn next to one of the great leaders on this topic and so many others here in the United States House of Representatives. Uh, his name is, as I mentioned, Ralph Norman of South Carolina. He is, among other things, uh, the chairman of the Conservative Opportunity Society, the truly bonafide conservatives in this Congress. He is also, I'm proud to say, um, one of

the men who was tapped as part of the effort to give conservatives more of a voice in the Congress, uh, a prized position on the House Rules Committee, which essentially makes the decisions about what legislation comes to the floor working, of course, with the speaker. Uh, Ralph Norman is a great friend of freedom and a member of the House Freedom Caucus, in fact. And we're delighted that he could join us to talk a little bit about his concerns about the who. Uh, he has organized several of the press conferences Chris Smith mentioned, and we're very proud to have him here at our first sovereignty Summit. Over to you, Congressman.

US Rep Ralph Norman: [00:40:30] Frank, thank you so much. I want to thank all the people listening and all the participants in. Uh, in this, I guess, call to action, you know, May 27th through June 1st in Geneva, Switzerland is a important date. It's in. Frankie, you said it right. This is about freedom. Preserving our freedom. There is. There is no more important issue than what we're battling now. Uh, and when you say surrender our sovereignty, guess who? We're surrendering it to? China. And I was a co-sponsor with Andy Biggs on H.R. 71, which was, uh, the Who withdrawal Withdrawal Act. Uh, what this calls for is the president to immediately withdraw the United States from the Who and prohibits, prohibits any use of federal funds to provide us participation in the Who. The most serious part of this, if they are able to move forward on this, the fact that they are trying to go around the Senate, uh, which requires a two thirds vote, it is a treaty. And anything that's agreed to would have to go to the Senate. Uh, secondly, article 55 and the bylaws I call them prevents any, any item of discussion to to come up unless we've had four months to review it.

US Rep Ralph Norman: [00:41:55] That hasn't happened. This is a bait and switch operation by the elites. And it's something we've got to call attention to. We got to stop it. The only thing that's going to stop it is those members in Congress, both the House and the Senate and the American people to rise up and say, we're not we're not doing this. We're not going. We're not taking part in the Who, nor are we going to surrender our sovereignty, uh, to a rogue group controlled by China, as we have seen with the Covid pandemic. So thank you for calling attention to this. We're going to continue to be a voice with more conferences. The fact that we're out a week, Congress is or the House is out next week when the conference takes place in Geneva, Switzerland is concerning, but it won't stop us from spreading the word. And doing this is speaks

volumes about the concern that so many of us have about this, uh, about about losing our freedom.

Frank J Gaffney: [00:42:58] Congressman, thank you very, very much. A call to action and one that we will be amplifying wherever possible. Uh, we appreciate your leadership, sir. Thank you for joining us today. Uh, we have with us, uh, Fernando Zani. I'm looking for what, little bit of a bio I have for him at the moment. Um, Fernando, are you there? And can you join us at this moment?

Fernando Zani for AR Deputy Beltran Benedit: [00:43:20] Thank you very much for your time and for this opportunity. Um, I am from Argentina, legal advisor from Mister Beltran Benedit, congressman. We are a new political party who has taken power on December the 10th, last year. And Mr. Benedit has clearly published a statement against a WHA agreement or a international agreement, international sanitary, uh, modifications. As you know, here in Argentina, we've had, uh, in 2020, pretty a dictatorship from the state where all citizens were locked during eight months. We weren't allowed to go out. We have arrests and our freedoms were forbidden. Therefore, as, uh, as part of Melaye's government, we are pretty aware of this, uh, who agenda and, uh, aims in trying to, uh, avoid our freedoms. Okay. So, uh, from our side, uh, the lack of transparency and the power transfer, uh, in this latitude, it's it's pretty well known we are making a huge effort, uh, for all the countries here in South America to be aware of this. Uh, in fact, the congressman is, uh, is giving huge of interviews, uh, to all media here, not only in Argentina but in neighboring countries in order to be aware about this, because there is a there is silence everywhere in, in, in this region.

Fernando Zani for AR Deputy Beltran Benedit: [00:45:03] So, uh, in order with uh, to, to to have a point is we should be very aware and make clear statements about that next week, uh, in the summit, everybody has to be, uh, has needs to make the follow of this one. Okay. There's a link where Mr. Benedict has, uh, published on his statement where this can be followed live. And a under the name Preserving Our freedom. So recommendations. So in order to end the my my speech uh, here in Argentina where impositions okay from the W.H.O. so this country and this um, particular this government is not going to sign anything which violates nor or, uh, conditions or freedom. Okay. So this is a, a point that I need to make it very clear. It was recently announced on social media, uh, by Mister Benedict where he, they published on Twitter

and on Instagram. So if you want I can share his statement and his publishes. Okay. Thank you very much.

Frank J Gaffney: [00:46:19] Um, Fernando, um, we are very pleased that you are in Argentina. And that is a very heartening message indeed that the government of and we've become great admirers of the new government, um, is not going to be going along with what the World Health Organization has in mind. Um, praise the Lord. Let me just say, um, we, uh, have with us. Uh, a number of others. And I want to just say if we could, uh, because there is such an important aspect of this, uh, in terms of kind of the fundamentals of what the World Health Organization is doing with the, it must be said, aggressive, uh, connivance, support and otherwise, uh, collusion of the Biden administration, uh, to subvert our own constitution here in the United States. And several of our speakers have touched on this, but we happen to have with us one of our country's greatest constitutional lawyers, men who's defended our rights in numerous cases before the Supreme Court, among many, many others. His name is Matt Staver. He is with Liberty Counsel, and I believe he's with us. And I would like to ask, um, your indulgence to hear from him. He's not a parliamentarian or a member of Congress at the moment. He should be. But he's doing vital work with his organization. And we're very pleased to have him to talk briefly about, uh, what's on the line here in terms of, uh, our country's constitution. And I suspect it will bear on that of others as well. Matt Staver, over to you.

Matt Staver, Liberty Counsel: [00:48:03] Thank you. Frank Gaffney and, uh, the members of the Sovereignty Coalition. And, uh, thank you for all the members of Congress, former members of Congress, and all of those, uh, around the world, uh, that have joined us today. Uh, this is encouraging to see all of you coming together. And I know you represent, uh, millions and millions more, uh, in your respective constituencies and in your countries. So at Liberty Counsel and Liberty Counsel action, we began messaging on this issue regarding the Who in 2022, when this began or came to our attention. Back then, there were a lot of people that said, oh, this is hyperbole. There's just no way that the W.H.O. would be able to gain global authority that's legally binding. But in fact, what we now see, and this is an encouragement, and I want to talk about why it's so important. Uh, there was a lot of silence for so many months and even years. But just in the last month or so, we've had 49 US senators sign a public letter opposing the W.H.O. over sovereignty concerns. We have over 60

members of the US House co signing onto a bill that would defund the W.H.O. and also require the W.H.O., like the Senate, to have a two thirds majority vote for any kind of international agreement with the Who. We have 22 state attorneys general that have signed on in opposition, expressing concern regarding loss of United States sovereignty and state sovereignty.

Matt Staver, Liberty Counsel: [00:49:34] We have 24 governors yesterday that issued a public letter stating the same thing that they're concerned with regards to the loss of sovereignty of the United States and the individual sovereignty of the states. I'll come back to that in a few moments. We have the United Kingdom coming on board saying they don't want to give up 20% of their various kinds of medical testing and other kinds of medical products, 10% that would have to be free, 10% that would be at nonprofit cost. They concern that issue of sovereignty as well. That is joined by 15 other nations that we know of, including members of the Parliament of Australia and Israel. Members of the Parliament of Israel are meeting today on this very issue, and many others around the world are then now speaking up, expressing the same thing that all of us are concerned with. And that is the loss of sovereignty. At Liberty Council, we were very much litigating some of the draconian, unconstitutional lockdowns in the United States. We represented the very first place of worship in the United States, where a pastor was arrested for a draconian lockdown in March, I should say March. Yeah, March. Last March of 2020, last, uh, week of March of 2020, we ended up, uh, representing, uh, places of worship in California, 100 and some churches in California.

Matt Staver, Liberty Counsel: [00:50:55] In California, you could go to a big box store and you could jam that store, be packed shoulder to shoulder, no problem. Garden hoses were considered essential potted plants the same. But going to worship, having a prayer meeting, a Bible study in a church, no matter how large the sanctuary was, it could be 5000. Doesn't really matter how large that facility would be. That was criminal in California for a year, and it was actually criminal to go into your neighbor's house, condo, or apartment next door. If you didn't live there or have somebody come into your house that didn't live there just to pray with that person, have a Bible study, or just encourage them. They were locked down by the governor while he was doing his birthday parties, uh, at tens and tens of thousands of dollars with his friends. Those kinds of policies came from. The United States Center for Disease Control, coming from the World Health Organization with the fictitious six foot distancing, all of the lockdowns,

what's essential and what's not essential, picking and choosing losers and winners of arbitrarily based upon their idea of what's essential, what's important. We litigated these over and over again. We saw people suffer. We saw individuals commit suicide. We saw athletes, for example, that were in their last year of high school and their whole career just seemed to be crumbling without any other support system.

Matt Staver, Liberty Counsel: [00:52:21] Unfortunately, we saw high school athletic stars commit suicide because of the depression that they experienced. They were locked down, not able to go anywhere in Florida. We took a different tack because of Governor Ron DeSantis, and Florida Governor Ron DeSantis said that the schools will open in in-person services and in activities in August, September of 2020. A lot of pushback, a lot of opposition. But you know what? Florida now is number one in the nation on education, because we didn't lock down and we didn't kill young people. They actually thrived and survived in Florida was a place of freedom. It was a bastion of freedom. And for so many people have moved and are moving to Florida as a result of what happened during those pandemic years. But now we went to the Supreme Court in December of 2021. We won in December, December of 2020, we won 5 to 0. We went back to the lower courts using our constitution. We lost again, went back to the United States Supreme Court, won 6 to 3 at the United States Supreme Court in a February of 2021 that ultimately resulted in the elimination of these lockdowns on churches, where they were picking and choosing abortion clinics over churches or big box stores being essential.

Matt Staver, Liberty Counsel: [00:53:38] But places of worship were not essential. That ended the draconian lockdowns because we were able to assert our sovereignty, our constitutional rights, and we got decisions from the highest court of the land that this was unconstitutional. It was a violation of our First Amendment. But if in fact, the W.H.O. gets its way, uh, we will lose that sovereignty, we won't be able to go to our courts in the United States to defend our freedom and our sovereignty based upon our Constitution, that the people have gathered together and adopted and that's preserved this country for so long, we would have to go to an international body, not using our laws, but actually using a foreign body's laws under the directorship of a Marxist who was, um, pushed out by disgraced from Ethiopia, put back into position of high authority because of China. Uh, that's Tedros. And he unilaterally would be able to declare what is a pandemic? And by virtue of the public health being so broad, would have the ability to

assert authority over everyone travel, trade, imports, exports, climate, you name it, whatever it might be, whether we can take a certain medication, whether we have to inject our body with a certain drug or vaccine at any given time.

Matt Staver, Liberty Counsel: [00:54:55] Consequently, uh, we would lose our freedom. So I encourage all of you, and I'm very honored to be with you to stand for this. This is the most critical time in history, because what we are experiencing is an attempt at a bloodless coup. This is a bloodless coup. But I can tell you what. If they are successful, the coup won't be bloodless later, because those who are resisters or dissenters who simply say this is too much, they will be punished. They will be persona non grata. They won't be able to travel, go to school, go to church, go to work. They won't be able to get food. They'll have to inject certain things into their body, all because of a foreign entity that takes control of 194 nations, for which we will have no recourse. So thank you for all you're doing. Thank you to the Sovereignty Coalition. And may this momentum that we see happen continue on through next week, and that this attempt with the pandemic treaty and the 300 plus amendments to the International Health Regulation, may it come to naught and may we gather together in the next couple of weeks, uh, on the other side of this with a victory and maintain our freedom. So thank you for all you're doing. God bless you all.

Frank J Gaffney: [00:56:18] Thank you, Matt Staver. Let me just say, the idea that we are being put in a position where, as Matt's indicated, we have documents that have not been finalized. The nations are supposed to be voting on next week is outrageous, and it seems, on the face of it, not only inconsistent with the regulations of the organization itself, but of course, contrary to any good order, rule of law. For, among other things, we have a Senator from Australia in the House. Um, I have no idea what time of day it is there, sir, but we're delighted that you're with us. His name is Senator Malcolm Roberts. Um, we've, uh, appreciated your patience with us in getting to this point. I'm delighted to welcome you to the floor. And thanks for all you're doing. Uh, Australia was, uh, an object lesson in what not to do in the course of a pandemic. It seems to me. But, uh, we'd appreciate your insights into both what's happened to you and what you don't want to have happen next. Over to you, sir.

AU Senator Malcolm Roberts: [00:57:28] Thank you very much. And thank you for the invitation to attend and participate to the organizers. Thank you so much for what you're

doing. I want to also thank the United Nations, World Health Organization and various national governments mismanagement of Covid because thanks to you, people are waking. I also want to thank USA former Senator James Inhofe and his adviser, Mark Murano, who protected sovereignty about 20 years ago with the carbon dioxide tax that would have been global to raise trillions of dollars for the United Nations. Sovereignty is vital. The two key structures for healthy human civilization are the nation state and the family. And the United Nations wants to destroy both. I was the first in Australia to call it out in April of 2022. I've been blessed with two expert staff who are strong in their knowledge about not only the UN World Health Organization draft treaty, the International Health Regulations and the process the United States United Nations is supposed to follow. What I want to do is discuss why I'm opposed to the treaty, and why we must all oppose the UN World Health Organization grab for power and control. First of all, health care. The best health care is personal because health is an individual's responsibility. When we need assistance. The best advice comes from a local advice healthcare practitioners with a direct personal relationship a local person. The next level, uh, involves running state hospitals or private hospitals. Public hospitals. The state is necessary. That's the the state as you know it in America, in Australia where a federation of states.

AU Senator Malcolm Roberts: [00:59:05] The next level. The federal government is terrible. It needs to stay out of health. Get the hell out of health altogether. The worst level is global. Remote, disconnected, uncaring, politicized, corrupt as experience shows. So let's move on to the United Nations and the United Nations world health record. Their record is atrocious. Tedros Ghebreyesus is a former terrorist. He's in charge. The Chinese Communist Party nominated him, and that raises questions of his impartiality and independence. He presides over what an internal investigation into into the World Health Organization has admitted. Rape culture exists in the in the World Health Organization. It can't run itself, let alone run the planet. They've also tried bribes to change African opposition to the to support the World Health Pandemic Treaty that has failed thanks to the African nation's previous experience with the World Health Organization. The United Nations is inhuman. It's responsible for thousands of deaths from big pharma trials in Africa. The United Nations is poisoned with a culture of politics and commercial interests driving the agenda and the lack of hard, empirical scientific data within a framework of logical scientific points. The United Nations in many fields destroys science, and the Who is simply an organization for hire. I want to turn to Covid

and the lies and the incompetence that we saw. First of all, the World Health Organization denied there was any problem at Wuhan. That was a straight lie. Secondly, they advised there was no human to human transmission.

AU Senator Malcolm Roberts: [01:00:39] Another lie. Then when Covid broke out across the world, the World Health Organization exaggerated the danger and the risk. We know that Bill gates owns the World Health Organization, a large chunk of it, and is a primary motivator and driver of the agenda. Gates and others use the World Health Organization to sell vaccines, injections, drugs. There are huge conflicts of interest that that they accept as normal and usual, which tells us about their corruption. With regard to the World Health Organization Pandemic Treaty itself, it breaches their own constitution in three three clear ways. First of all, for such a vote as we're facing this week, there needs to be four months notice before the vote that we've only had one month's notice, so it breaches its own constitution. Secondly, the World Health Organization has no jurisdiction under its constitution within a nation, and that's what they want jurisdiction within a nation. They breached their own constitution the second time. Thirdly, the World Health Organization is meant to be an advisory body only, only for advice, and only upon request of each member state government will they enter a country. No compulsion, no action, another breach of their constitution. It is with great shame. I've admired the United States as a country. I've lived and worked in the United States. I'm married to an American. Our children are dual citizens. I've been in all 50 states. I love America, I admire America, but the American government has really the one that needs to be held with shame because they initiated the changes.

AU Senator Malcolm Roberts: [01:02:11] And shamefully, our Australian government at the time supported the changes in the World Health Organization. It cedes sovereignty. And what we've seen is the uni party, so many people in Australia, in the Liberal Party and the Labor Party supposedly in opposition, form a uni party and push the globalist agenda. We see the red and blue, so many traders in both the red and the blue parties in America and in Britain, joining together to push the globalist agenda. I'm very proud to have signed a letter with Alex Antic and 12 other senators and Members of Parliament that were sent to our Prime Minister last week, urging him not to sign the treaty. We do not want a treaty. The party I'm proudly a member of, One Nation wants to protect and unify a nation not handed over to global terrorists. As others have echoed, the global control is the aim of the World Health Organization. A man called

Maurice Strong had two aims. He was very senior UN official unelected socialist global governance. I mean he stated this and to de-industrialized Western civilization, that's the madness these inhuman people are pushing. Many UN senior bureaucrats have echoed this, this statement. Christiana Figueres from the UN Framework Convention on Climate Change, Ottmar Edenhofer from the United Nations Environmental Protection Advisory Committee, and Antonio Guterres himself has said he advocates for a global order that works for everyone. New world order. It means control what we're seeing.

Frank J Gaffney: [01:03:38] Senator, if you'll forgive me, Senator, we we are. Over time. I hate to cut you off. You have made a magnificent presentation, and we need to hear that kind of clarity. And I'm hoping that the government of Australia will heed it as well. Um, we're going to move to another of our leading members of the United States Congress, another man whose leadership is being profoundly felt in this institution. His name is Bob Good. He represents the people of Virginia. I'm proud to say that, uh, we have some property in his district, so I consider him my congressman and couldn't be more proud of him. He is, among many other things, the chairman of the House Freedom Caucus which is the other bastion of real freedom fighters in the United States Congress, along with Ralph Norman's conservative Opportunity Society. We're so appreciative that he's been able to drop by. He's schedule is, uh, incredibly chock a block. We're going to turn to him quickly for some comments about the WHO, about which he has become one of the leading experts here in the United States Congress. Over to you, sir.

US Rep Bob Good (VA-05): [01:04:51] Well, thank you, Frank, and I appreciate your leadership on this and for inviting me to participate, of course, as Frank noted, that he's my constituent. So he's kind of my boss. And he told me I had to be here and participate today. No, he and I have done many things together on this, and I appreciate his leadership over the last year. I often say this is the most important issue that is the least talked about relative to its importance. And in our country, at least in the United States, I think it's because of the stealthy or covert nature of the way this administration is approaching this. I happen to believe that a strong America is a good thing, that America being. I would submit the first world power that didn't use it for nefarious purposes, or at least to conquer others around the world. The United States certainly has not done that with the way that we've been blessed with being the leading economic and military power in the world. So I think a strong America is good for the world. I don't

think that is believed across the board by those in our government. And you can see how folks are coming down on this issue in particular. And sadly and unfortunately, it is partisan where we have the Democrats who seem to be, uh, supportive of the United States surrendering its sovereignty to the W.H.O..

US Rep Bob Good (VA-05): [01:06:01] They didn't learn anything during the harm that was done by governments and by once respected entities during the Covid pandemic. How the government hurt us by many of the things that were put in place, and W.H.O. was at the forefront of that. President Trump was right to have previously defund the W.H.O.. And then, of course, Joe Biden got us right back involved as a nation. But the Joe Biden, his administration, and unfortunately, I'm a partisan guy. Many Democrats, they don't believe in American exceptionalism. They don't believe in American sovereignty. No greater evidence of that than is with our border invasion that they are literally facilitating on purpose some 3 or 4 million illegal aliens coming to our country. Poorly or little, if any, vetting done to those irreparable harm has been done to our country. Only time will tell. They don't believe in preserving the American culture, the American way of life, our values, our founding principles. And that's why they do what they do. And here we are with this, uh, threat, here with the with the W.H.O. sovereignty issue. And again, I'm privileged to be part of this sovereignty summit. Uh, but we are trying to bring attention to it, trying to, uh, raise the alarm, trying to build awareness.

US Rep Bob Good (VA-05): [01:07:12] We're thankful that, uh, roughly half of our governors, sadly, all of them Republicans, roughly half of our AGS, sadly, all of them Republicans and roughly half of our senators have come out against it. I don't know any Republicans in the House who support this. Again, we're trying to get it, uh, more prominent. Uh, there's many challenges and battles that we're fighting. But to focus on this issue, I'm proud to support my friend Chip Roy's bill to once again defund the W.H.O.. I'm proud to be a co-sponsor of that bill, along with my friend Tom Tiffany's bill, uh, to require Senate ratification. We certainly should not ratify this. We shouldn't do it. It's not good for the World. It's not good for the United States. Uh, but again, I happen to believe that an America first United States policy is a good thing, just like every other country's policy should be. But the Democrats and the administration don't believe that. But certainly we shouldn't do it. But we also, if we did do it, it certainly or consider doing it, I should say it ought to require Senate ratification be considered a treaty, not an

agreement. And so we're encouraged that at least got delayed. But we're very concerned about the pending vote for next week.

Frank J Gaffney: [01:08:16] Thank you, Congressman. Good. Um, good is an apt term for him in every sense of that word. And we're very appreciative that you've been able to join us, as well as with the leadership that you really are providing in our Congress. We're going to go to Poland next. And this is a name that I know I will massacre, Grzegorz Placzek, I believe it is. He was hoping to be with us in person. I'm sorry that didn't work out. Perhaps in the 2.0 version of the summit, we will have more participation from overseas. But we're delighted to have all of you joining us by the miracle of zoom, when it is miraculously working. And we're going to go to you now, member of Parliament in Poland and a leader of, I believe, a faction of some 18 that have been very forcefully opposing what's going on with the World Health Organization. We're proud to have you with us, sir, albeit virtually over to you.

PL MP Grzegorz Placzek: [01:09:13] That's so true. A warm welcome to you. Okay, unfortunately, I have only two minutes, but I believe because this meeting is recording, I will be, uh, I will find more minutes later on to be able to listen. All speakers. My name is Grzegorz Placzek and I am a member of Polish Parliament this term. As a part of my work in the Parliament, I have formed a parliamentary panel of organisation issues. So far there have been four meetings of the group during which we have discussed, apart from the issues related to the reform of international health law. Other disturbing phenomena with uh, who is responsible responsible for uh, these include guidelines for children's sex education and transgender ideology. And I'm closely following the activities of World Health Organization and the process of negotiating its two instruments of international law the pandemic agreement and the proposed amendments to the Ihr Health International Health Regulations. Uh, we find it hard to believe that some of the proposals for amendments to the, uh, Ihr, uh, have been presented to the public, for example, uh, you know, the one I'm sure that everybody is aware of it, uh, including article three to delete, delete the requirements to delete.

PL MP Grzegorz Placzek: [01:10:45] Let me repeat it. The requirements to implement these regulations with full respect for human dignity, I believe freedom and rights. So, uh, what implicates my concern is the who's overstepping of article 55 of the Ihr, which should guarantee us people as, uh, as member states, the knowledge of the final

version of the proposed amendments, which are prepared, as we all know, uh, for approval at the seven 77th World Health Assembly. And, uh, to to conclude, I'm also and we also worried about the rush in which these two instruments are negotiated, and we believe that they should be subjected to further analysis and public debate. So, um, what I'm trying to send to tell you now, I'm sending you the message from Polish, from Poland and from Polish Parliament that there are also, uh, parliamentarians who are aware of what who is working on at the moment. And we are against it, and we are trying to, uh, inform other parliamentarians. And if there is any way for the for further steps, we can together cooperate and build the huge group of parliamentarians from all over the world to fight against these amendments we are in.

Frank J Gaffney: [01:12:11] Thank you very, very much. Um, again, we're sorry this was not in person, but we're delighted to have had you, uh, this way. And thank you for your leadership in Poland. Um, we're going to go next to a special guest. I wasn't sure whether he was going to make it or not, but we're delighted to have him here. Um, he is the national security advisor to the speaker of the House of Representatives, Mike Johnson. We are delighted to have you here to make a short presentation on behalf, I believe, of the speaker. Welcome.

Joshua Hodges, NS Advisor, Speaker Mike Johnson: [01:12:43] Thank you. Joshua Hodges. I work for Speaker Johnson, and he is he is the the person who matters. I'm here on his behalf. He wishes he could be here. Uh, he appreciates all of the work that you all have been doing over the past several months, and especially the last several weeks, to gain momentum across the United States and globally. Uh, this is an issue of vital importance. We believe American freedom is at risk. And we we took some very valuable lessons learned from Covid 19 and all the trials that we've endured over the past several years. Um, these decisions are impacting American freedoms and should be decided by Americans. Uh, we're under his direction. We are working with the House Foreign Affairs Committee to advance legislation that will require that this be considered by Congress and the Senate as it should be, as you all have been advocating for today and over the past several weeks and months, this is an issue that we have seen increasing support for across the United States, globally, as we engage with foreign leaders from around the world. This is an area where there is unity that the decision being pushed right now by the administration is out of touch. Uh, it we should not follow the Chinese model. We know that is a bad model. It is something that will endanger

American freedoms in the long term and the near term. It will endanger American businesses. And so for all of those reasons, thank you for everything you're doing. Um, again, I'm here on the speaker's behalf. Thank you for all of your hard work. Thank you. Thanks.

Frank J Gaffney: [01:14:14] Please give our regards to the speaker and our thanks. Moving some legislation on this issue would be very much appreciated and hopefully will further intensify the pressure not to accede to these, uh, um, well, these agreements that we still don't know the contents of incredibly, um, we're going to hear from, uh, another speaker from Italy. And this is an exception to the general rule. We're trying to get as many nations represented as we can. But, uh, Lucio Malan is a serving member in the Senate of Italy and has been a forthright critic of what the Who is up to and I hope is going to be influential with his government in this regard as well. Uh, Senator, we're delighted to have you with us. The floor is yours.

IT Sen Lucio Malan: [01:15:09] Thank you for all the organizers. Thank you to Senator Ron Johnson. I'd be very, very brief. Uh, first of all, I confirm what Senator Borghi already said at the beginning of the session. Uh, that is that the Italian government is oriented against the the both the former and the new text that's been proposed, both for the pandemic treaty and for the International Health Regulations. Uh, second point, I, uh, want to stress the point that article 55, paragraph two of the International Health Regulations says that, uh, any amendments should be, uh, should be given to all state parties four months before the discussion in the health assembly and which has not been done because, of course, the text of April is just a few weeks ago. So there is a, uh, a problem of procedure that has been violated. It is could be violated if these such amendments are introduced in the assembly of, uh, of next week. Third point, um, all the acceptance of either the pandemic treaty or the international health regulations that are, uh, self, uh, they automatically. I'm sorry. Enforce I can. Are implemented imply a heavy financial burden Italy and I think all the countries have provisions. We have it in the constitutions. Other countries have it in in the laws that any burden, any expense must be covered by, uh, with the provision of law. And so I think that any government, if is willing to join to under that I think has not been requested that I encourage uh, all the colleagues, uh, who to do to do the same. Thank you very much. Thank you for giving a place to to the second Italian.

Frank J Gaffney: [01:17:13] You can't have ever too many Italians, as far as I'm concerned. You're driving on the roads, I assume in Italy, and that you managed to get through there without any mishaps. Um, God bless you, sir. And the work you're about.

Frank J Gaffney: [01:17:30] I'm going to introduce once again, Reggie Littlejohn, the co-founder of our Sovereignty Coalition and, um, an attorney who brings a degree of expertise on particularly these international and human rights related matters. Um, and we're always pleased to have her comments, uh, particularly Reggie, on this point about whether we, in fact, are witnessing a breach of the international health regulations themselves, as they are, about the business of transforming them so fundamentally that they're unrecognizable in terms of what they had been before. Reggie, thank you.

Reggie Littlejohn: [01:18:14] Thank you very much, Frank. So basically, we are at war. This is unrestricted warfare. And at this point it's bloodless. But as one of the previous speakers, uh, alluded, you know, who knows what could happen in the future? We are at war for our national sovereignty and our personal medical freedom, and to stop the World Health Organization from turning the world into a global totalitarian biotech police state. So. In many ways, the World Health Organization is the weaponized arm of the Chinese Communist Party, the United Nations, the World Economic Forum, and the entire globalist cabal. And the way that they're going to effectuate this is under something that has called one health. So one health is an innocuous sounding concept that unifies human health, animal health and plant health. And what it does is it then it can be used as a pretext for the World Health Organization to, um, surveil all aspects of life on Earth human health, animal health, plant health and anything that relates to them. So they they could say that, um, gun control is, is, is a public health emergency of international concern or, uh, so-called, you know, reproductive rights or depression or climate change. Basically, everything comes under the purview of the one of the W.H.O. through One Health. And it's a balancing of these, uh, health aspects. It's not the human health wins. It's human health has to be balanced against animal health, uh, and, uh, plant health. So according to the Lancet magazine, all life is equal and of equal concern, which means under one health, which is in the pandemic agreement.

Reggie Littlejohn: [01:20:03] Your health, my health, the health of our loved ones is equal and of equal concern to the health of a rat or a cockroach. Now, how are they going to find out if there's a pandemic anywhere in any of these areas? Through

surveillance and the agreements obligate countries to surveil, uh, basically every aspect of life on Earth, um, and to counter misinformation and disinformation that is in an annex of the International Health Regulations. And those these terms are not defined. So, uh, they could use it to counter anything that is counter narrative to what the World Health Organization is trying to get out. And how will they enforce it? They will enforce it through digital IDs, the digital ID, this is from the World Economic Forum website, and digital IDs will be needed to open bank accounts, travel, shop and transact business on a communications device like a cell phone or a computer, to participate in social media, to pay your taxes to vote, and to collect government benefits, for example, Medicare, Medicaid, Social Security. So this is a tool of complete and utter surveillance and control, very similar to the China one, the China Social Credit system. And so I believe that that these these agreements are basically a pretext for, uh, instituting the China social credit system worldwide. So how do we stop it? Well, as Frank alluded, they the World Health Organization has has broken their own rule.

Reggie Littlejohn: [01:21:46] Rule 55, article 55 and the International Health Regulations requires that all amendments to the World Health, the International Health Regulations, have to be disclosed and distributed to the various nation states four months in advance. They completely blew that deadline. And so therefore it is now illegal. It is unlawful for them to be voting on these international health regulations and also on the pandemic treaty, because they are intertwined. And so many of you have signed, you know, this letter basically voicing your opposition. I would I would ask that any nation that opposes this should consider signing what is called a dispute between nations. This is an official legal dispute, and all it takes is one brave nation to say we dispute this directly to Tedros. And then if he doesn't resolve the issue, then they can kick it up to the International Court of Justice, and that will have the legal effect of tolling, uh, this vote. So and any country in the world can do it. And if anybody wants, uh, a draft letter that I have that was drafted by outstanding European lawyers who know what they're doing in this regard, I can send it. And the letter is already written. It's airtight. And it's it is the only way to actually legally stop this vote from happening on May 20th 7th to June 1st. Thank you.

Frank J Gaffney: [01:23:14] We're going to talk with another distinguished parliamentarian from Hungary. And we're very pleased to have, Dóra Dúró with us.

Deputy General Secretary Janos Argyelán, for VP Dóra Dúró: [01:23:24] Greetings from Hungary. Hello, everyone. Can you can you hear me? Well, my name is Janos and I am the deputy general secretary of our Homeland Movement from Hungary. So I'm a speaker for Vice President, MP Dóra Dúró. And we are in the middle of campaign of the European parliamentary and local elections. So she had to leave early. But I'm talking on her behalf. So our party is a conservative national party in the Hungarian parliament, and we have six MPs in the parliament. We are the third most powerful party, in the country. And there is only one party that is our homeland movement. That is our party who has raised concerns about the NWO dictatorship. In Hungary, both the government and all the Liberal parties together at the moment support the ratification of the pandemic treaty. So what we are doing, we are trying to raise concerns against this risk, public concern and to catch the attention of our political fellows to change their ideas and open up their minds and open up their eyes. Well, what's the problem? What is our problem with the pandemic treaty? We believe that if the treaty is signed, the WHO will have an exclusive competence on all matters, and they will classify what a pandemic is, what is meant by pandemic. It is their decision. Also, they will decide and they have decided about the protocols, what will be used mandatorily for the states to implement. In other words, under the treaty, we can imagine that they will be able to order surveillance, closures, forced vaccination, even quarantine, and they can impose as other punishments.

Deputy General Secretary Janos Argyelán, for VP Dóra Dúró: [01:25:29] They can even deport people or lock them up in camps if we disobey them. And that's only part of the story, because what makes it even more filthy, uh, is their leader, Tedros Ghebreyesus. Uh, as a leader of a health organization, he doesn't even have a medical degree. Uh, he was the leader of an extremist terrorist organization in Ethiopia, which was involved in numerous genocides. And we have no doubt that he is doing the same thing now. He's preparing to carry out another genocide. Uh, what can we do to to stop this? We have to put as much pressure as possible on governments, on the world's governments, to stop the ratification of this treaty and act in the interest of the people. No amendment of the treaty are acceptable, acceptable to us. Uh, in Hungary, we have our homeland movement has organized, uh, demonstration against the HW on the on the 11th of May in Budapest, our capital, which was a huge success. And also we regularly participate in events, demonstrations, conference all over the world. Like there was one, for example, uh, a huge event in Switzerland on the 7th of April. Uh, in sum,

we can say that we are trying to open up eyes, uh, open up the people's eyes. They try to open the. We try to impact public opinion. We try to open up our fellow politicians eyes to see what's going on and what the problem is with this, uh, pandemic treaty. Thank you very much.

Frank J Gaffney: [01:27:11] Thank you. It's good to have you with us. And thank you for substituting so handsomely. We're sorry that we ran out of time with your boss, but please express our appreciation for her participation earlier in the program.

Frank J Gaffney: [01:27:26] We're going to go back to Reggie Littlejohn, who had an addendum to her remarks. That's very important. And I want to make sure that we are able to take advantage of, uh, both the expertise that went into the letter that she earlier referred to and make sure that it's available to all of you.

Reggie Littlejohn: [01:27:43] So, as you know, Honorable Michele Bachmann is here. And she took me aside and said, look, why not put it up on the Sovereignty Coalition website so that everybody can see it? So I am going to, uh, forward this letter to the Sovereignty Coalition website, and, and it'll be put up. Everybody can, uh, look at it and sign it. I would say that is a dispute between nations. So the the dispute is that the Russian nation said, oh, you know, we complied with article 5518 months ago when we submitted the 306 proposed amendments to the International Health Regulations. And that's not compliance. That's absurd. It's supposed to be the final text that is, uh, that is submitted for consideration. So, uh, Argentina, if you're still listening, um, please seriously consider doing this. This is a way that one nation can throw a wrench in the works and stop this, bring this whole thing to a grinding halt. Thank you.

Frank J Gaffney: [01:28:42] That, of course, is our purpose to bring this whole thing to a grinding halt. Thank you, Reggie. We're going to go to a member of the European Parliament representing the people of Croatia. Another name to be mangled, I'm afraid. Ivan Vilibor. Sincic. Maybe the floor is yours.

EU MP Ivan Vilibor Sinčić: [01:29:07] So thank you, colleagues. A lot of members of European Parliament who are supporting this initiative. I'm also very grateful to Senator Johnson and Sovereignty Coalition for hosting this event in US. And this summit is, of course, providing a much needed platform for elected officials from around the world to

address the proposed was indeed deeply problematic. Pandemic agreement and proposed amendments to the W.H.O. International Health Regulations. With every passing day. More facts, more truth is being exposed regarding Covid crisis and health officials involved. Just a few days ago, there were big news about Mr. Fauci lying once again to the people of United States, but also the world. W.h.o. is highly dependent on private funding, such as Bill and Melinda Gates Foundation and others. The influence of such foundations shadows a combined influence of hundreds of nations across the world, including my home country, Croatia. With every passing year, who cares less and less about public health and medical science, and more about globalist political goals, power grab and promoting certain medical products. One of the big donors of the Who is European Commission, which has failed the people of Europe in Covid crisis. They made disastrous deals with Pfizer and other big pharma companies. They lied about vaccine safety and efficiency and now they avoid any kind of public hearing. Wasting tens of millions of euros and experimenting on hundreds of millions of citizens. Cries for accountability. Who has completely failed humanity during Covid crisis and must be held accountable? They were trampling human rights and medical ethics and operated more as a PR agency for the Big Pharma.

EU MP Ivan Vilibor Sinčić: [01:31:02] We do not want to experience what we experienced during Covid crisis ever again. We must not give them an opportunity. I fully support defunding the Who. I support postponing the vote and finally exiting the Who. We must stop this power grab by the Who, which wants more control, more power and more money. They want to build their own laboratories all around the world, and if they do that, they will misuse them. They will be proclaiming pandemics left and right and responsive measures in order to control nations and push them towards their globalist goals. If they gain power. This global health authority could declare any threat a global pandemic. They could force everybody to a quarantine or experimental vaccines. It could again introduce control and suppression of different opinions or any critical opinion. They could limit travel, border crossing and finally they could declare a global lockdown. And this is just the beginning. It is extremely dangerous to allow the Who to limit our civil rights. I want health policy making to remain within our national institutions. I am against anything that could further reduce the sovereignty of my home country. These people. You who were speaking today, who will be speaking today. We are standing for democracy, transparency, sovereignty, scientific truth and against

corruption, global power grab and scientific fraud. I am honored to be among you today. Thank you so much. Thank you.

Frank J Gaffney: [01:32:40] It's great to have you with you, with us from the European Parliament, uh, as we've had a number of nations speak to us who are members of that Parliament. Um, it's, uh, an exercise in supranationalism. And an awful lot of Europeans, I think, have found that it is wanting. And so thank you for what you're doing on behalf of the people and the nation of Croatia.

Frank J Gaffney: [01:33:07] We have, I believe, one last, foreign contributor. I beg your pardon? Calling it in from the sidelines. Two last foreign contributors. Anil Hegde from India. And, would that be a member of the Indian Parliament by any chance? Well, we are welcoming you, whoever you are and whatever rank you have in the Indian Parliament, I understand. Thank you very much for bearing with us. And the floor is yours, sir.

Hon. Aneel Hedge from India: [01:33:52] Thank you, Ron Johnson for organizing this zoom meeting. First of all, I thank, Lisa Renberg and the Awaken India Movement in India. I thank Mr. Reddy, Aruna Rodriguez and others for introducing me to this issue. And, I'm proud that I was able to raise this issue. I spoke against the global pandemic treaty in the Indian parliament on the second of February this year. And, the health minister has replied to me, which was not satisfactory. I replied to him, and I have also written to the honorable Prime Minister of India on this issue. I do not want to take your time. You're all doing a very good job creating awareness. Thank you so much.

Frank J Gaffney: [01:34:51] I know that the Prime Minister is still, I believe, in the midst of a reelection campaign. And it might be something that would move him to act in the way that Reggie Littlejohn has just talked about. Perhaps at the minimum to express his non concurrence with what is being done if not actually objecting to the whole process. But thank you for joining us and representing India.

Frank J Gaffney: [01:35:21] We have with us, a medical doctor who has been one of the most important members of our coalition, really, from its inception. She has been a front line doctor, recognizing that she is among those who have been made to feel the pressure of the medical establishment and the other authorities over the years that

she's been trying to stand up for her own patient's rights and make sure they got the proper care. We're appreciative to her for her continuing service with us, as well as for her leadership in the medical space in any number of capacities. Her name is Doctor Kat Lindley and Kat, we'd love to hear from you a little bit about your thoughts on the patient doctor relationship, and how it might be impacted by what is afoot in Geneva next week.

Dr. Kat Lindley, DO: [01:36:28] Thank you, Frank, and thank you all for coming and representing your countries. Um. I'm doctor Katerina Lindley. I'm president of Global Health Project, and I was actually born in Croatia. The thank you, Minister, for being here today. Um, I practice in Texas and I've been concerned about the World Health Organization. It's really since 2022 because of some of the proposals that have given us, and in particular, the article 18 really affects the care that we can give to our patients. According to the article 18 of the International Health Regulations. The director general can declare public health emergency of international concerns. Once he does that, he can order lockdowns, travel restrictions, vaccine passports that now they call travel documents but also interfere with patient physician relationship by telling us what type of medications we can use, diagnostics and ultimately vaccines. According to the internet, to the World Health Organization. We are going to be in this perpetual state of pandemic, and there's going to be initiatives to create more and more of this, uh, mRNA platform vaccines in 100 days with the minimum to zero liability. As we all know across the world, the World Health Organization has failed at their job, which is pharmacovigilance.

Dr. Kat Lindley, DO: [01:37:52] So promoting new vaccines on this mRNA platform does not make any sense. As Reggie said, they also want to do surveillance of pathogens and then ultimately sharing of these pathogens with potential of gain of function research. So yes, there will be more and more pandemics, but the same thing will happen that happened during Covid 19. It is. Extremely necessary for all of us to, like many of you have said, define who. I'm actually not up to the reform. I'm one of those things that we do need to exit the show, because ultimately, with one health agenda, they want to become global authority on health on Earth, and we need to make sure that that does not happen. The track record is abysmal, and we need to work together as nations, and we need to represent our people and the people have spoken. If you really talk to everyone and explain what's happening, no one wants the World

Health Organization to. In charge of our health. So thank you all for being here today. And thank you for all your leadership across the world. Thank you Frank.

Frank J Gaffney: [01:39:04] And Lily and your leadership around the world has been incalculably important, has introduced us to many of the people that we've been speaking with today. So again, back at you. We're going to hear next from a Member of Congress from the Philippines. I'm not sure whether I've got that right. Philippine Congressman Dan Fernandez. You've been very patient, sir. We're appreciative of you staying with us, and we give you the floor now.

PH Rep Dan Fernandez: [01:39:33] We'd like to thank our friends and our partners at the Sovereignty Coalition for sponsoring this forum where we elected officials across the globe could galvanize our collective stand against threats to our democratic way of life, our national sovereignty, and our personal medical freedoms. It is encouraging to note that the members of your own Republic Governors Association in the United States have joined in united opposition to these controversial proposals. We in the Philippines Congress have, uh, initiated investigation on the reported hundreds of thousands of excess deaths in our country in 2021 and their possible causal connection, the vaccination efforts of our government. At the same time, we have raised issues of transparency, accountability and adherence to national interest with respect to the proposed pandemic treaty and the International Health Regulations. For these purposes, we have filed proposed legislation, as well as appropriate House resolution, to trigger congressional inquiries on these very urgent concerns. I have authored the House bill number 9563, entitled That act requiring any convention, agreement, regulations or Other International Instrument on Pandemic Prevention, Preparedness and response reached by the World Health Assembly and or to be implemented by the World Health Organization to be deemed a treaty subject to Philippine Senate ratification. I have also sponsored House Resolution number 1481, entitled Resolution Directing the Committee on Public Order and Safety to immediately conduct an investigation into the 297,000 excess deaths in the Philippines in 2021, based on data from the Philippine Statistics Authority, as the possible cause of such deaths threatens public order.

PH Rep Dan Fernandez: [01:41:23] By putting into question the overall safety and efficacy of the response of our health care system during the time of pandemic. Further,

I have initiated House resolution number 1490, entitled resolution, expressing the sense of the House of Representatives to urge the government to reject the amendments to the International Health Regulation adopted on May 27th, 2022, and the proposed amendments that are currently being negotiated in secret and due for adoption next week, as they pose a threat to public order and safety, being violative of well established protocols and prejudicial to our fundamental democratic principle. During our congressional investigations, some of which I have initiated as most appropriate inquiry, as chairman of the Committee and Public Order and Safety, we have tried to summon the representative of the World Health Organization in our country to shed light on the various issues surrounding the proposed pandemic treaty and HR amendment. But to my dismay in his reply, he invoked his immunity to any inquiry and legal process in accordance supposedly with the Who Constitution. One can just imagine then, if this is presently the stance of the W.H.O., what would happen if such body is further empowered as a super governmental authority on matters of health? Its leadership probably could easily ignore state concerns and escape official scrutiny and accountability. Dear colleagues, even if we give the W.H.O. and the World Health Assembly the benefit of the doubt, even if we assume that they are sincerely motivated by the desire to deal with the unimaginable ravages of future pandemics, we need to warn them now that they are going about it all wrong.

PH Rep Dan Fernandez: [01:43:09] If they think that democratic values, national sovereignty, personal freedoms, and requirements of transparency and accountability may all be sacrificed by the altar of medical expediency, then we have to differ strenuously. Friedrich Hayek, the renowned philosopher economist, once said that in our attempt to shape the world according to our wishes, we often produce the very opposite of what we intend. I think the sentiment Hayek would like to express is that airports impose comprehensive social planning can lead to outcomes that are antithesis of the desired improvements, sometimes resulting in oppression and loss of freedom. In other words, in our desire to bring down heaven and earth, sometimes to create the worst kind of hell, we must insist that we have a very reasonable proposition to the W.H.O.. We are simply asking to delay or defer the pandemic treaty or agreement and the air amendments until adequate deliberation and consultation are conducted under the rule of law and the ages of transparency or full disclosure and accountability, we say reasonable in view of the lack of time for notification or dissemination and the multiplicity of provision or amendments involved, we in the Philippines will continue with our due

diligence. While we are the property of a rule based international order, we do not want the rules to be skewed or stack up against our time honored values based on democracy, human rights and national sovereignty. Thank you so much and good day. Thank you.

Frank J Gaffney: [01:44:48] Very well said. We're going to hear next from one of Matt Staver's colleagues. They have an operation that is bringing, I think, to bear both the intellectual capital that you were treated to from Matt earlier in the program, as well as a little bit of political muscle, if I can call it that. John Stemberger is the president of the Liberty Counsel Action, and we wanted to hear from him briefly before we move to our last two speakers from overseas. John Stemberger welcome. Thank you. Frank.

John Stemberger, President, Liberty Counsel Action: [01:45:23] So, Liberty Counsel Action represents millions of Americans who are very concerned about the lack of transparency, the lack of due process, and the lack of proper communication. And I just want to highlight one aspect of this, and that is the word stealthy has been used over and over again. That's exactly correct. Um, this proposal is unaccessible largely to the average citizen. Um, they don't even know what the World Health Organization is, much less its scope of its power, its influence, who controls it, who owns it. So this is not something that's accessible to even politically aware people. I mentioned the other day just the word who and they said, is that a rock band? So I mean, it's just really something that's not accessible to the average voter. Even the average informed voter has no idea this is going on. And so it's very concerning in that way. The media is largely ignoring the issue, not covering it. And when they are covering it, not covering it fairly or accurately in terms of the scope and the danger of what's involved, and certainly not covering the dissenting opinions that are being expressed here today on this particular program. And so the problem is it's simply unbelievable. The scope is so large, it's so magnitude, the power being given to the Who in this situation, in some cases of an academic pandemic or even some other crisis that they determine, climate change is one of the things that could trigger their power, by the way. It's just simply unbelievable. And this is a major problem because if you're unbelievable, it seems to be uncredible.

John Stemberger, President, Liberty Counsel Action: [01:46:46] So really have to explain to people the amount of control, the breathtaking nature of what this is. It's

almost diabolical. And it's almost it's like when you when you hear it, it's like, oh, that can't be true. When you hear people how understand how broad this is, it seems like some kind of a diabolical plot from a villain on a marvel movie or something. It really is remarkable. So I would say to all of those watching, if you have networks, social media networks, we just need to call people to action. We need to increase awareness. Um, and I just want to do you take my time to just say, this is a call to action. We need to inform people. We need to promote the Sovereignty Coalition's website. We need to get the content from this particular presentation out. This is not factual fiction. This is fact. This is real. And we need to let people know that. Um, and then the final problem with it, it's a contingency power. This makes it even more troublesome because it's not something that takes effect immediately. It takes effect when the subjective sense of whoever thinks that there's some kind of a crisis, whether it's a climate crisis, what's LGBT crisis? The scope of the power here is just enormous. And so we should just alert people to this, uh, Frank and let them know this is not a good thing. We need to oppose it.

Frank J Gaffney: [01:47:59] John Stemberger, we've been trying to do that. And I thank you very much for giving us further encouragement. Let me just say, personally, I don't believe in the history of mankind, there's ever been somebody who has had more power over more people—unchecked, unaccountable, and potentially utterly tyrannical—than would be the case if these treaties, either one of them or both, were to be adopted by the World Health Assembly next week. It's all the more remarkable that in the history of the world, so many people have had ambitions to control the world in the way that Tedros Ghebreyesus could. But they've had to use force of arms to try to get it. In this case, it's simply being surrendered to this individual, and I think we've established fairly well in the course of these various comments. He is unworthy of any power, frankly, even the kind that he's exercised. To date, indeed malfeasance in the case of the Covid 19 pandemic especially. We're going to turn to an former member of the Canadian parliament, Maxime Bernier.

Hon. Maxime Bernier, Leader, People's Party of Canada: [01:49:20] Hello. My name is Maxime Bernier. Yes, I was a former foreign affairs minister under the conservative Harper government in 2007, 2008, and I left the conservative in 2011 to create the People's Party of Canada. Now I'm the leader of the People's Party of Canada. We are the only national political party in Canada at the federal level. Uh, that was against the,

you know, Covid hysteria, draconian measures, uh, during Covid. We are fighting for freedom and less government. And it's sad that in Canada, the so-called the conservative under the new leader and the liberals are in line with the pandemic treaty. Uh, the conservative leader in Canada, uh, won't speak about that. Uh, actually, for us, that's part of our DNA. We created that party based on individual freedom and personal responsibility, fairness and respect. And our goal is to put Canadian first and fighting for Canadian sovereignty. So that's why I'm very pleased to be with you and to fight for national sovereignty across the globe. And as you know, right now, here in Canada, the Trudeau government is one of the worst, uh, government, uh, Trudeau government, uh, showed us that is is a dictator, a kind of a dictator, authoritarian.

Hon. Maxime Bernier, Leader, People's Party of Canada: [01:50:54] And we have obligations in Canada against the free speech and more censorship. And, uh, Trudeau and his government and also the opposition in Canada, the conservative are adamant about what is happening right now and what will happen in the next couple of days in Geneva. So the People's Party will fight against that pandemic treaty. Our goal is to withdraw from that treaty and regain our sovereignty, withdraw from the Paris accord, withdraw from the Migration Compact. We want Canada to be sovereign and governed by Canadians. If that treaty is signed, as a lot of speakers said, that will give more legitimacy, more, uh, uh, autonomy to non-elected, uh, globalist bureaucrats in the UN and in the world, uh, Health Health Organization to dictate their socialist policies to other countries like us in Canada. So I hope that our, um, our movement will be successful. We are there to fight for people all across the world, and I'm very pleased to be part of that. So thank you very much for giving me your time. And let's, uh, stay strong and free and fight for our citizens.

Frank J Gaffney: [01:52:17] Thank you for joining us. And thank you for the leadership. You're, uh, you're exhibiting in Canada. We've, uh, we've been very concerned about the direction of your country under what? As you've said, it seems to be an increasingly totalitarian regime operating at the national level. Uh, if one can only imagine what it will become if it has this overlay at the supra national level. So Godspeed in your work. Uh, we have, uh, a very much anticipated speaker from the Israeli Knesset. I had the privilege this morning of joining Senator Johnson. Uh, he by video me in real time, uh, in a debate that was taking place, uh, in the Knesset. I understand it was an unprecedented debate in that it was open ended. It had gone on for a couple of hours

before I got to it, and it seems to have carried on. Uh, Ariel Kellner is his name. And we're, um, extraordinarily appreciative of the leadership he has been exhibiting inside the Israeli parliament. Um, at a time such as this. Uh, needless to say, as we spoke of earlier in the program, uh, if you have a Tedros Ghebreyesus, um, authorized to declare anything, he chooses a public health emergency of international concern and then dictate what must be done about it. Looking very, very quickly at his recent comments. You see that Gaza is likely to figure as one of those public health emergencies, and one can only imagine what he would do to the government of Israel, to the people of Israel, to the nation of Israel, where he in a position to dictate the response that it must take. We've speculated a little bit about this, Ariel. You may wish to comment on that or more generally, about what is the current attitude of the Israeli Knesset and people. And the upshot of this very important debate earlier today. Welcome, sir. Thank you. Over to you.

IL MK Ariel Kallner: [01:54:36] Thank you very much. Distinguished participants, dear friends. Um, as you said, I'm a I'm a real culinaire a member of Knesset in Israel. Uh, thank you, first of all, for organizing this significant event. Um, our commitment is to defend, uh, our nation's sovereignty, our citizens freedom, and our democratic institutions. Uh, since, uh, the dawn of humanity, there is there has been a clash between nationalism and imperialism. The imperialism seeks to homogenize the humanity into a uniform shape. Um, opposing. Directly opposing the essence of nationalism. We in Israel are now in a war, uh, with the radical Islam, which is an imperialistic movement and imperialistic ideology. Make no mistake, Israel is just the first in line. The West is next, and the free world should stand with us in this war. However, the global governance is another imperialistic movement. In this w h W.H.O. accords oppose a real threat to the sovereignty of our nations. The global governance is a modern imperialism. The efforts to shift power away from national governments to international institutions represent a serious risk to our liberties. We need to stand together in this struggle, and I'm sure that a global coalition and global objection will succeed and will succeed in dealing with these threats. The minimum, the minimum, I expect the minimum we need is that it will be emphasized in, in the Accords that. A the that the courts will not violate the sovereignty of the states according to the way they define it. This is the minimum we expect, I expect, and the this is the minimum we need to stand on. So thank you very much. And then good luck to all of us.

Frank J Gaffney: [01:57:15] Well, we wish you and the people of Israel the best of luck as well. I must say that, um, you will find people who are proponents of all of this pointing to provisions that more or less claim that there will be no diminution of the sovereignty of member States. Um, I, for one, would not be satisfied with such a declaration, especially when essentially every other aspect of both of these documents, um, is evidence of diminished sovereignty and a very, very serious threat to it indeed, as we've been talking about throughout this program. Um, our last foreign speaker, I believe, is Wybren van Haga, uh, a former member of the Dutch parliament. Over to you.

Hon. Wybren van Haga, former NL MP: [01:58:11] Well, first of all, thank you very much, uh, for organizing this, uh, sovereignty summit. And it's very good to see that there is a growing resistance, um, to the power grab by our socialist and globalist friends. Uh, my name is Vibrant Van Haga, and I'm a Dutch candidate for the European Parliament in Brussels, and I'm a former member of parliament in the Netherlands. And that is to say, for the past six years, until the last elections in November 23rd. Um, I am very proud that I was the first and for a long time the only MP to question the Covid 19 charade and all the dystopian measures that were imposed on us by our government in the Netherlands. My party is bvnl and we try to protect simple rights like private property, freedom of speech, and we want to reform the European Union to the extent that member countries maintain their sovereignty. Countries have to be sovereign in many aspects such as food, water, energy, immigration, military capacity and of course, on the issue of health care. And that is exactly why my party party strongly opposes the current Collectivistic coup, which is about to take place by the World Health Organization. On the 1st of June in Geneva, the World Health Organization will vote on several amendments and a new pandemic treaty, giving the Who and its Ethiopian director general, Mr. Tedros, a dystopian amount of power. And the Who will gain legislative power, and there is no possibility to seek justice in court.

Hon. Wybren van Haga, former NL MP: [01:59:38] National health sovereignty is transferred to the Who and if this becomes reality, we'll be facing mandatory W.H.O. lockdowns. Whenever they will, there will be another questionable virus rearing its ugly head. And if Mr. Tedros decides that there is a public health emergency of international concern, any measure can be forced upon us. From lockdowns to curfews to closing schools again, to mandatory vaccination and vaccination passports. The Dutch

government has unfortunately already announced that they will agree with everything the Who has proposed. Our life as we know it is at stake. Democracy is currently at rock bottom as the amendments have not been run through Parliament for months in advance as was required. Therefore, Bvnl will fight this hostile collective coup by the Who tooth and nail. Because if we lose our freedom now, we will be forced to live in a one health dictatorship run by the Who. And that is why Bvnl will be in Geneva during the W.H.O. summit to try to prevent this Orwellian totalitarian system from being introduced. Join us, fight with us, and vote for Bvnl so we can continue to fight for our rights in Brussels, for our freedom against all these unelected bureaucrats in the EU, the United Nations and the World Health Organization in the interest of all our countries, and of course, in the interest of the Netherlands. Thank you very much.

Frank J Gaffney: [02:01:06] Thank you. And we're delighted that you were able to participate in that. You're getting back into the arena, which is of vital importance.

Frank J Gaffney: [02:01:17] It seems to me again, at a time such as this, we have it turns out another member that is in the room and identifiable who we would like to call upon. And I have to establish where he is from, Barrow Island and where we're going to find Andrew Bridgen. I don't at the moment, but I the gentleman I think that I just identified, if you are with us, Barrow Bugled, over to you and identify where you are from, sir, please, if you would.

EE MP Varro Vooglaid: [02:02:00] Yes, thank you very much. I am a member of parliament from Estonia, a small country in Eastern or Nordic Europe. And, um, since last spring, really for one year. And unfortunately, only conservatives speak out against the globalist power grab in Estonia, including the power grab of the w-who. Uh, besides being a member of Parliament, I'm also a lawyer, and I run a small legal center by which we have taken a good number of cases to the courts to argue that vaccine mandates were unconstitutional. Uh, but when doing so, we have seen the repetition of one and the same pattern time and again. The courts have stated all the time that the limitations on constitutional rights, most of all vaccine mandates, were justified because the government based them on the recommendations of the W.H.O. and other international bodies, which the court, uh, will not question, the competence of which the courts will not question. This is how the mechanism is to function, and this is why it is so dangerous. In the end, we will be incapable of defending any of our rights in courts

because, you know, the recommendations of the W.H.O. stand outside the sphere of criticism. Unfortunately, I have no good news to bring you from Estonia because our government is, uh, very so-called liberal and, uh, completely loyal to the globalist agenda.

EE MP Varro Vooglaid: [02:03:33] We are an independent state only in theory. In reality, they do everything they're told to do. So and no questions asked. So, uh, the change really needs to come from the United States, I suppose, because let's let's face it, this is where the globalist center is located. Um, of course, of course, we need to be opposed to the international pandemic treaty and the new version of the Ihr. But I think we also need to raise a more fundamental question about why we need, as countries, to belong to the W.H.O. in the first place. If it is, uh. Developed into a globalist mechanism whereby to impose on all countries in the world a globalist agenda. I don't think we should belong to such an organization in the first place. If it is to be restored as a platform of cooperation for the mutual good of countries, then of course we can discuss under what conditions we still want to be part of that endeavor. But this is really what I would like to emphasize in addition to what has been stated by the others. Uh, we don't necessarily have to belong into such international bodies, which are only. Set up to destroy freedom and sovereignty. So thank you very much to everyone who is working. To contribute to this movement. Thank you.

Frank J Gaffney: [02:05:08] Thank you. And I apologize for not knowing where you were from, but we're very pleased to have you from an important Baltic nation. A small, yes, but very strategic. And we're privileged to have had your participation. We are getting calls in from the sidelines, and I'm trying to make some sense of it. I believe that there is a tribal leader in Uganda by the name of Danny. Steven Zakari who has been patiently waiting. And I apologize for not having, called you sooner, sir. I gather His Royal Highness is the appropriate title. So that should have gotten you better placement in the pecking order. But we're delighted to have you with us, sir. If you'd like to speak, the floor is yours.

HRH Drani Stephen Izakare, Uganda: [02:06:06] My only one thing, my one concern. Let me start from the initiation of the World Health Organization. And I thank everybody at the Sovereignty Council. For bringing this topic into the light of people. I know, I'm, uh. I would appear to be at the lower bastions of community leadership. But however, I

just want to thank. All the people in the struggle. To cause this nonsense to disappear. If you are not living in a movie. We are living real lives. And the lives of our people matter. And, um. The World Health Organization, which was brought together to run, uh, the idea inceptions of it, uh, started in 1946. And are completed concluded upon in 1948, with several countries joining. It was actually an ally of China and Brazil, I believe. In 1948, several 61 odd countries had joined and it was ratified and uh, made. Uh, the issue is, um. This organization now was made as an organization, and it was given a committee and stuff like that to to work on global health issues. And this should never mean that they have more authority than a single state. Rather, whether it is South Sudan or the newest state in the world, or whichever state it will be tomorrow. They are not superior to that.

HRH Drani Stephen Izakare, Uganda: [02:07:54] They are servants in administrative roles to our nation's. Then they're supposed to give technical advice and all these kind of things. Number one um. Secondly is that, um, we I come from Uganda, but I'm a leader of a tribe. We have, uh, various tribes in Uganda, which made a covenant to to be together with the British. And then they formed the Uganda Protectorate. That means we are individual nations of peoples that have come together to do that. Um, so that means that we have even a deeper the issues of, um, animals, environment and, uh, plants and stuff like that, superseding the our human rights and our human needs as we see them in Africa, then we don't believe that these human needs are going to be dictated upon by a few people that sit, whether the excuse of, uh, an organization called W.H.O., World Health Organization or the World Economic Forum or at different places, uh, I don't believe it's excusable and it should never happen. And so I, I just say that, uh, you cannot take away a civilization that is thousands of, like, such as ourselves through junior, is what I'm saying now. Must be known by these people. And they must know that all the wealth they garnered dividing amongst themselves.

HRH Drani Stephen Izakare, Uganda: [02:09:37] This is a money of nations that are giving to this World Health Organization. And so any other wealth that comes from the World Economic Forum membership or the Bill gates and all this kind of stuff, that is their moneys which they have made in this, um, dispensation of our global current economy, uh, thing. And it was made by people that work within organized institutions. So we should not be taken for fools or for a ride. This is what I'm this is my message today, World Economic Forum, all all to the World Health Organization. Uh, they've

broken the the rule number 55, section two of the Human Rights International. You cannot be an organization that is accountable, that goes on breaking rules. Who are you? These nations formed you. You're not bigger than the nations. So we, the the people who are in these nations have allowed it to be there. And you don't come from your own, your you don't have a country that you you can say that this is you do not come from heaven to land on us. We formed you to help us our situation. So I'm saying that, um, this World Health Organization is time now countries. Instead of struggling to find a meaning of this whole thing, uh, we should really look at what is the World Health Organization, what is its usage as it departed from the purpose for creating it? So that we can, um, look at how we shall go on, uh, to have a meaningful health organization on the continent. I mean, on the Earth, because it's our planet. But we all come from different environments. We have lived in through different, um, dispensations, times and space that have allowed us to evolve. And, everything else that, uh, that goes with that. So we appreciate our history and our identity. Our sovereignty is our identity. So, I think let me stop there in the interest of time. But I would have a lot more to say. But God bless you, everybody that's on this forum.

Frank J Gaffney: [02:11:55] We appreciate you being with us. And thank you for patiently standing by. I understand we have yet another last guest, um, Sorin Manchu of the Romanian Parliament. another mangled name, I'm afraid. But if you are still with us, sir, uh, the floor is now yours.

RO Dep Sorin-Titus Muncaciu: [02:12:16] Yes. Thank you very much. I'm, uh, grateful to Senator Ron Johnson for inviting me last time in the Senate to, uh, testimony to to testify. But right now, I'm. I'm trying to show you right here. You can see this is the minister of Romania signing on the 26th of April, a bilateral treaty with the W.H.O.. And if you look to this little booklet here as a sign, it says. I don't know if you can see it, but it says. W.h.o. country cooperation strategy. What does it mean? If you look on the Facebook on W.H.O. on the 26th of April? They proudly say that they sign a bilateral treaty with Romania, which is consist of um, strategy, cooperation, strategy from now to 2000. And uh. 20 and 30. I am afraid that they start doing something different. And that's for. That's why I'm bringing this up. The treaty was signed by the Ministry of Romania, which is here on the left, and the Mr. Kluge, who is the representative of W.H.O. in Europe.

RO Dep Sorin-Titus Muncaciu: [02:13:53] I'm concerned about that, uh, especially for the fact that the European, um, establishment doesn't give enough attention to that. And I give you an example, was last year, me and, um, Lord keen from British Parliament, we submit to European, uh, to the Council of Europe in Strasbourg a motion to study the treaties and the and the International health regulations, because I was convinced that egregious, uh, human rights violations are allowed in those, uh, uh, amendments and, and, uh, and therefore I was. Waiting to see the action that the Council of Europe will take. And I remind you that Council of Europe is that organization of 47 years ago who is dealing with democracy, rule of law and human rights. And, um, I'm very displeased to the fact that they did not the bureaucracy in Council of Europe actually stopped our motion. But now this is a new development. Uh, and, um, you can check it out. It's, uh, on the 26th of April, Romania signed a strategic cooperation, um, treaty with W.H.O.. And, of course, I was asking to the minister of Romania to say what is in this treaty? And if.

Frank J Gaffney: [02:15:31] You'll excuse me. Sir, we are now at the risk of being thrown out of the room. I think because we've extended so long, we do have a final speaker, and I want to thank our speaker from Romania. He made a very important intervention in Senator Johnson's last informal hearing. And, we're glad to have you with us, sir. And thank you for being again patient with us.

Frank J Gaffney: [02:15:54] Our last speaker is Joe Gebbia. He is a member of our sovereignty coalition, uh, former businessman who has now turned his considerable talents and resources, uh, to the task of saving our country. And he's done it with extraordinary effect. Um, mention has been made by Senator Johnson, among others, of the remarkable, uh, well, uh, momentum that has been built in recent days. And I think it's no exaggeration to say a great deal of that is thanks to the work of Joe Gebbia with States Shields, an organization he founded and is now the CEO of, uh, his his efforts have borne fruit, particularly with these 22 attorneys general and also with now 24 governors. Um, there may be more coming. I think he may mention some of coming attractions, but this is a this is an extraordinarily impressive example of someone who has, uh, like the fabled Cincinnatus of Roman times, uh, put down the plow and picked up the sword to go fight on behalf of his country and our freedoms. And I couldn't be more proud to both call him a friend, as well as a very, very valued member of our sovereignty coalition. So, Joe, over to you.

Joe Gebbia, President, State Shield: [02:17:24] Thank you very, very much, Frank. I want to acknowledge you for your leadership. You and Reggie, co-founders of Sovereignty Coalition. And it's amazing the way this coalition has really put under one silo a lot of different people. We're now accessing the talents from multiple people with over a thousand people on the ground and just for edification purposes, um, we started putting this event together as late as only last week. We got calls, Frank and I, from several members of government around the world saying we need America's help, and we had not been involved previously with dealing with the international community. Uh, except for obviously, I take that back. Members of our sovereignty coalition have been over petitioning a lot of Parliament members in around the world. Uh, but we never really interacted at this level. So it was apparent that there was a voice that needed to be heard. They were looking for leadership from America. And I can say quite candidly, uh, some of the things that have happened that I think have expressed that leadership domestically, um, as Frank has alluded to and it's been mentioned several times today, is there's been an outcry allowed statement. Um, and some of the examples are, first, the 49 senators have Republican senators have combined in unison to state their opposition to President Biden. That was followed by 22 of our attorney generals in our 50 states have also sent their letter of protest to the president.

Joe Gebbia, President, State Shield: [02:18:59] Uh, that's significant because that's the legal arm that will initiate activities that need to be had. On top of that, we had, uh, 24 Republican governors through the Republican Governors Association, uh, just yesterday released their letter, which is a tremendous that's half the country for the United States. And then that's at the federal level, at the state level, at the state level. Um, we've had a lot of activity at states, and I'll point out just a couple of key ones, and this momentum is really picking up, and we're going to see a lot more as the year unfolds. But the state of Louisiana, single state. But still, it was the first state in the nation to actually issue a bill which is legal now, a law that. Denies jurisdiction to the Who in their state. We've had multiple resolutions in the state of Tennessee, State of Alabama and others pending here, coming out soon, protesting the acts of the Who and what the threats could be to the States, and the potential loss of sovereignty and being able to manage their own health care system. So the United States is really rallying and hopefully making statements through our different entities. But this here is a loud

statement that we're able to put across to the world. So this is a very, very significant I want to thank everybody for coming and attending today.

Joe Gebbia, President, State Shield: [02:20:16] And I can say without any hesitation, the world has finally had its day to speak its mind. And your voices have been heard, have been heard loud and clear. Uh, you revealed we've heard repeatedly, um, many of the same issues from different corners of the world. But to recap quickly, I think I was taking some notes. Some of the issues that really need to be attended to is the first is transparency. Our discussions have made clear that the Who's efforts has been shrouded in darkness. Absolutely no doubt of that. Today you are demanding greater transparency on all fronts, with an undeniable show of respect for the rule of law and procedures that has not been had. Public policy should never be made behind closed doors, as it seldom produces policies in the best interests of those it was intended to help, and more often creates policies that only benefits the policy makers. And we're seeing that. Second issue was trust. The exercise of government relies on the trust of those who are governed. The W.H.O. is an agency brought into existence by permission from the independent countries entrusted to improve the health of the world's population. But it has broken that trust and repeatedly. How? As mentioned by a lot of the speakers today, by collaborating, by collaborating with bad actors to cover up the source of the Covid 19 virus by its pandemic malfeasance.

Joe Gebbia, President, State Shield: [02:21:51] Recommending Covid policies not premised in scientific fact, but instead designed to minimize the rights and the freedom of individuals and promoting dictatorial demands for lockdowns, vaccine passports, business and school closures, travel restrictions. And you've heard the whole litany of the list there it goes, on and on and on. The Who's leadership lacks accountability to the sovereign nations that have given the organization its public health role. Role. Today, you, as the world leaders, are demanding real accountability and are sending the message that to regain the trust of the world, the Who must become more accountable on the issue of excessive power. The role of the Who is to promote the policies that improves the health of the world. We have seen, however, that its leadership is more interested in consolidating their own power base and creating a one world order in which they are the power brokers. The recent wholesale dumping of any phrase or term deemed potentially hazardous, hazardous to getting the new EIR proposals approved, demonstrate that they are more interested in accumulating power than they are in

serving the people of the world. As the old saying goes, power corrupts. Absolute power corrupts absolutely. Having demonstrated inability to properly exercise a little authority, the Who should certainly not at this point be trusted with authority and these agreements.

Joe Gebbia, President, State Shield: [02:23:28] That these agreements would give it. The bottom line is the Who proposals created in the dark and rushed through not due to public need, but rather to to aggregate power to the Who's director general. Are not ready for prime time. There is certainly a need for nations to cooperate on these issues, but this is not the way to get there. So there's a bigger picture. Just make sure everybody understands that goes on here. We're talking about a single incident, a single situation here about trying to deny the Who the opportunity for this power grab and to create what, in essence, would become the first existence of a new world order. This is part of a whole scenario of events that are planned to unfold throughout the world. In the next one, as it was also mentioned, was the United Nations meeting this fall, which is going to be seeking similar type of powers for the director there within the United Nations. It starts here. It certainly doesn't end here. If this gets approved and it's just going to morph, and the rights and freedoms of the world will continue to be denied regularly. This has to be stopped. And I thank all of you for your attendance. And I'm going to turn it back to Frank now.

Frank J Gaffney: [02:24:51] Thank you Joe. Very well said. Um, I'm going to close it out, if that's okay, Reggie, just to make sure that we don't get thrown out. Lock, stock and barrel here with breakage of equipment, among other things. Um, this has been an extraordinary event. And I'm very proud that despite some technical difficulties and delays and all the rest of it that we did, I think achieve the purpose, which is to demonstrate that there is a world now rising up in opposition to the World Health Organization's clandestine agenda to become the dictator in the person of Tedros Ghebreyesus of public health policy internationally, uh, as I think each of our speakers has, in their own way made very clear, this is totally unacceptable. And one of the things that is so important to understand is it couldn't possibly be happening. If this were being done above board. If anybody in the world was actually given an opportunity to do what our friends in Israel have just done today, which is to become aware of the. Well, uh, silent coup, I guess, is what somebody described it as, uh, the the takedown of our sovereignty. Um, I appreciate the patience of each of our speakers, especially those

who were with us for the better part of three hours, um, who have contributed so much to our understanding of their national perspectives on this and helped us as our own, uh, parliamentarians, our members of Congress and the Senate, um, have informed the world about how there is now a rising opposition to all of this on the part of American leaders.

Frank J Gaffney: [02:26:55] And I want to again, thank Joe for his efforts in that respect. Um, showcasing this is this is real. It has been formalized. And what we now need to do is make sure it translates into a bipartisan opposition to what's going on here. I personally believe I'm an old Scoop Jackson Democrat going back many, many years that there are Democrats. There are certainly independents who love this country every bit as much as do the Republicans who have signed these letters. I call upon them as part of this larger, worldwide rising opposition to what the World Health Organization, the World Health Assembly, will be trying to do next week with the active support of the Biden administration to call a stop to this. Not now. And whenever it does happen in this country, if it does in fact eventuate, that it not be inflicted upon our people without the formal advice and consent of their elected representatives in the United States Senate and a similar process, I hope, everywhere else around the planet. With all of that said, again, our thanks, especially to this incredible team, our revered colleague Dede Lawson and Oleg at Bastion and Justin Johnson and so many others who've made this possible. Um, it only was possible with their help, and it almost wasn't even with it. So we're especially grateful for their patience and and tenacity. But again, thanks to this audience, and I hope to those who will be watching this program in the days to come. Uh, those are precious days before freedom is potentially snuffed.
